



New Generation Biofuels Privacy Policy **25th May 2008**

Maintaining the privacy of your information is important to New Generation Biofuels (“NGB”). This Privacy Policy describes NGB’s current corporate policy on how we use the personally identifiable information (“personal information”) that you provide to NGB through newgenerationbiofuels.com. You should read the entire policy carefully. By continuing to use newgenerationbiofuels.com or by providing NGB with your personal information through the website you consent to this Privacy Policy.

On occasion, NGB may revise this Privacy Policy to reflect changes in the law, NGB’s privacy practices, or the features on Newgenerationbiofuels.com. If any such changes impact the way we collect or use your information, those changes will be posted in this Privacy Policy and the effective date will be noted. Therefore, you should review the Privacy Policy periodically to remain aware of NGB’s current policies and practices. If NGB materially changes its practices regarding collection or use of personal information, your personal information will continue to be governed by the Policy under which it was collected unless you have been provided notice of, and have not objected to, the change.

1. Collection of Personal Information

This Privacy Policy covers personal information collected from and about you on newgenerationbiofuels.com. Personal information includes information such as name, mailing address, email address, and telephone number, and can also include the type of comment, and any additional information you provide to NGB. The information you provide is used by NGB to notify you about, and improve, the services that we provide.

In addition to personal information, NGB collects IP address, aggregate user data, and browser type. This data is used to manage and improve Newgenerationbiofuels.com, track usage, improve services, and for security and monitoring purposes.

2. Use and Disclosure of Personal Information and Your Choices

We may use your personal information for a variety of purposes as described in this Privacy Policy. If you do not want us to disclose information in this manner, do not submit your personal information to us.

NGB will not use your personal information for purposes that are different from those purposes detailed herein unless we ask for your permission to do so. In addition, NGB will not share your personal information with third parties who are not affiliated or partnered with us unless you have chosen to receive specific information and the fulfillment of such a request requires the sharing of your personal information.



Disclosure Within NGB and to NGB's Service Providers. Within NGB, we may share your personal information with NGB employees, agents, and contractors who have a legitimate business reason to obtain access to your personal information. NGB may share your personal information with outside contractors or agents who help us manage our activities, but they may only use your personal information to provide NGB with a specific service and not for any other purpose.

Legal Authorities. NGB may disclose personal information in order to protect NGB's or its affiliated entities' legal rights; to protect the safety and security of visitors to Newgenerationbiofuels.com; to protect against fraud or for risk management purposes; or to comply with law or legal process.

Corporate Transactions. Going forward, we may acquire or sell assets, and companies may acquire financial interests in us. In connection with those transactions, personal information may be among the transferred business assets, and we may disclose your personal information to any company in connection with a proposed or actual sale, merger, transfer, or exchange of all or a portion of a business or operating unit. Any such disclosure will be conditioned on that company agreeing to use the data prior to any acquisition solely for the purpose of making its acquisition decision and to observe the relevant provisions of our Privacy Policy with respect to the data. In the event that personal information is transferred to a company acquiring assets from us, we will require that company to agree to observe the relevant provisions of our Privacy Policy with respect to your personal information.

3. Security of Your Personal Information

NGB uses reasonable measures to safeguard personal information in its possession against loss, theft and unauthorized use, disclosure or modification. In addition, NGB uses reasonable methods to make sure that personal information is accurate, up-to-date, and appropriately complete.

4. Links to Other Sites

Newgenerationbiofuels.com may contain links to third party sites not controlled by NGB or covered by this Privacy Policy. NGB makes no representation or warranty as to the accuracy of any information contained in any hypertext link to those sites. Any hypertext link to any other person or entity should not be construed as endorsement by NGB of such person's or entity's website, products, or services.

5. Access to Your Personal Information

If possible, we will let you review your personal information that you provided to NGB and will take reasonable steps to correct any personal information that you inform us is incorrect. If you ask NGB to stop using the personal information you provided to NGB, NGB will honor that



request while retaining any record of your personal information that is necessary to comply with applicable federal, state, or local law.
